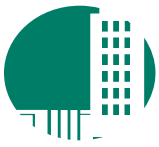

Legislature Receives Revenue Forecast Updates



Legislators received a pair of updated revenue forecasts on Tuesday, March 16. Legislators last received forecasts in

November 2020. These revenue projections are used by lawmakers to guide the budgeting and appropriations process.

The forecast presented by Moody's Analytics and the state Office of Management and Budget expects the state to receive nearly \$4 billion in oil tax revenue during the next two-year budget cycle — a full \$1.1 billion more than a projection presented to lawmakers in November. The projection assumes 1.1 million daily barrels

of oil production at per-barrel oil prices of \$53.50 in 2022 and \$48.75 in 2023 — much higher than the \$40 estimate lawmakers have used as a baseline since January. Moody's projection also predicts a \$54 million increase over the previous forecast in General Fund revenue, which mostly comes from sales tax, income tax, and a sliver of the oil tax.

The legislature's budget consultant, IHS Markit, offered a separate forecast that predicted similar levels of General Fund revenue. The firm brought up several scenarios for oil tax revenue, including one in which the administration of President Joe Biden shuts down the Dakota

Access Pipeline. That would mean higher oil transportation costs that hurt North Dakota companies and drive down production, one analyst said. Senate Appropriations Chairman Ray Holmberg, R-Grand Forks, said lawmakers will just have to be conservative in determining spending levels to account for the added risk.

Legislative leaders will likely use the two projections as "guardrails" to come up with a "conservative" amount that lawmakers can spend and propose the figure to the appropriations committees later this week, Holmberg said.

Legal Spotlight

U.S. Supreme Court to Hear Case About Student Off-Campus, Online Speech

This past January, the U.S. Supreme Court agreed to hear a case entitled *Mahoney Area School District v. B.L.*, which originates out of Pennsylvania. The issue in the case is whether a public school district may discipline a student for a social media post criticizing the school that is published off campus. The school district appealed a decision issued in June by a federal court in Philadelphia that ruled in favor of a high school student who had posted a vulgar message on Snapchat after she was placed on the junior varsity cheerleading team instead of the varsity squad. Once the school became aware of the post, the student was removed from the cheerleading team.

Student online speech is becoming an increasing concern for all districts as it is one of the primary methods for bullying behavior. The current

state of the law on regulation of student speech that occurs outside of school makes it unclear when and the extent to which schools may address such conduct. For the last several decades, the standard announced by the Supreme Court in *Tinker v. Des Moines Independent Community School District* has been the law of the land and used to determine when schools may regulate student speech. In *Tinker*, the Court upheld the right of students to wear black armbands to protest the Vietnam War but allowed some ability for school administrators to regulate speech that would materially disrupt the work and discipline of the school. The high court has narrowed student speech rights in a series of cases since *Tinker*.

To date, however, the U.S. Supreme Court has not directly addressed whether schools may limit or address online, off-campus student speech. Many lower circuit courts have issued rulings in several cases each rejecting the argument that *Tinker* prohibits regulation of off-campus speech. The rulings from these courts still apply the *Tinker* standard and generally require some sort of nexus to the school environment in order for the school to be able to regulate.

In the *Mahoney* case, the student sued the school district arguing her First Amendment rights were violated when she was disciplined for her social media post. The student won at the district court level and again in front of the Third Circuit Court of Appeals. In its decision, the Third Circuit said that *Tinker* categorically did not apply to off-campus speech, and thus schools could not discipline “speech that is outside school-owned, -operated, or -supervised channels and that is not reasonably interpreted as bearing the school’s imprimatur.” This is a clear departure from other federal circuit courts

that addressed similar issues of off-campus speech and the school’s ability to regulate under the *Tinker* analysis.

The National School Boards Association, along with several other national school administrator and educator groups, filed amicus briefs in the *Mahoney* case supporting the Pennsylvania school district. These groups are urging the Court to overturn the Third Circuit’s ruling and continue to apply the *Tinker* framework as interpreted by the majority of federal circuit courts to allow schools to address student speech that adversely impacts student learning and the school environment.

The Court will likely hear arguments in the *Mahoney* case this spring with a decision possible by June, though the court sometimes puts off some cases granted in January until the next term. NDSBA will continue to update its members as further developments occur in this case. Public Notice – NDDPI Accountability Waiver Request

On behalf of the State of North Dakota, the North Dakota Department of Public Instruction (NDDPI) will be submitting a waiver for the 2020-2021 school year of accountability, school identification, and related reporting requirements in the Elementary and Secondary Education Act of 1965 (ESEA).

Due to the continued extraordinary circumstances created by the COVID-19 pandemic and resulting impacts on students, educators, and

schools, the U.S. Department of Education (ED) invited states on February 22, 2021, to apply for a waiver and provided a template in order to streamline the process. The NDDPI believes it would be beneficial to North Dakota schools and districts to pursue this waiver.

The ED requires states to provide all districts and interested parties in the state with notice and a reasonable opportunity to comment on this waiver.

Business Manager Certification Program Accepting Applications

The North Dakota School Business Manager Certification Program (NDSBMCP) is now accepting applications for new students to begin courses later this summer. This certification program is a two-year, 61 credit professional development program geared toward new and long-serving business managers. Business managers are provided practical education and training to help them successfully perform their duties and meet statutory and regulatory responsibilities.

Courses are taught by superintendents, business managers, school district personnel, and state officials with expertise in specific areas. Course delivery is a mixture of face-to-face, virtual, and self-paced online. Instruction topics include: Introduction to School Finance, Open Meeting and Records, School Law for Business Managers, and School Elections.
